Minutes of the Committee Meeting held on Tuesday 3rd September 2013

- Present: Vhairi Cardinal (Chair); Alysia Trackim (Vice-Chair); John Dance; Pamela Parish; Grace Slattery; Jean Taylor; Richard Thompson; Bob Young. From the Hatton: Rob Airey and Hazel Barron-Cooper
- 2. **Apologies**: Julie Brown; Simon Court; Kelsey Thornton; Marion Thompson.
- 3. **Minutes**. The minutes of the meeting of 23rd July were accepted as a true record.
- 4. **Matters arising**: Vhairi had spoken to Caroline Coode who was very pleased to have been invited by FotH to do a retrospective for the 2014 Summer Show.
- 5. **Gallery Report**: Rob brought along a limited edition print (6/25) which had been produced in the 1960's entitled 'memories of an art school'. The print had been offered to the Hatton by the artist. Rob explained that as there was no acquisition's fund he and Hazel were seeking the support of the Friends to purchase the work which was offered at £249. However, he pointed out that the Curator, Julie was not happy with the quality of the print.

Vhairi deferred a decision the item to any other business.

Rob left the meeting and Hazel presented the Gallery Report, referring to a new brochure produced by the gallery setting out the programme of events leading up to Christmas. She highlighted a number of significant shows planned for the autumn.

Hazel also clarified the position about gallery art work sales stressing that the commission was retained by the Hatton and not sent to TAWM. She was also in the process of putting together an 'audit trail' to clearly track income from sales etc.

In apologising for Julie's absence due to other commitments she suggested it would be helpful if the Friends committee meetings could be scheduled at regular calendar intervals. This would enable Julie to plan out here diary well in advance. A decision on this was also deferred to any other business.

- 6. Treasurers Report: John had secured £352 in gift aid and combined with an income of £602 from entries to the 2013 Summer Show produced a new balance of £8120. He pointed out that gift aid in future years would need to be done on line but it seemed the system did not host 'MAC' Although this clearly created additional work load John intended to persevere, given the amount of additional income gif aid represented.
- 7. **Membership Report**: Richard reported that to date membership details in terms of numbers were:

One honorary member, Tom Shakespeare had moved out of the area and although the loss to the membership was regretted it would not impact on finances.

Richard also pointed out that 23 members had not been reported as having paid subs for 2013. It was intended that these be checked finally with John and memberships terminated for those who remained in default.

8. Events

Jean reported that Caroline was happy to continue to do a workshop next year.

The winter exhibition planned for 6th December had been discussed with Dan Baker from the Hancock. Jean thought it would be a good idea to have the official opening between 4pm and 5pm then move to the Hatton for light refreshments between 5pm and 7pm. This proposal received general support from the committee

- c. After having received a request from one member for Richard to email the membership about an exhibition being planned. it was agreed that any similar requests in future should be put on the website as the FotH data base was restricted for FotH activities only.
